

## DEPEX MALAYSIA “A FU-TASTIC CELEBRATION” CONTEST

### OFFICIAL TERMS & CONDITIONS

1. **ELIGIBILITY:** The “A FU-TASTIC CELEBRATION” Contest (the "Contest") organised by Sun Jiang Trading Sdn Bhd (the “Organiser”) is only open to individual citizens and permanent legal residents of Malaysia, who are eighteen (18) years of age or older, as of the beginning of the Contest. Employees of Organiser and Administrator (both defined below), and their respective parent companies, affiliates, subsidiaries, officers, directors, employees, contractors, representatives and agents of Organiser, and each of their respective immediate families and household members (collectively the "Contest Entities") are not eligible to enter this Contest.

2. This Contest is in no way sponsored, endorsed, administered by, or associated with Facebook and the Contest Entities, and all Entrants release Facebook from any liability in connection with this Contest. By entering, Entrants hereby agree to look solely to Organiser with any comments or issues. It is further understood that Entrant is providing personal information to the Organiser through its Administrator, (defined below), and not to Facebook. To participate in this Contest, each Entrant will be subject to the Organiser's Terms & Conditions and Privacy Policy where applicable. However your use of the Facebook Platform may also subject you to the Facebook Terms and Conditions (<http://www.facebook.com/terms.php>) and Privacy Policy (<http://www.facebook.com/privacy/explanation.php>). Please read these terms before entering. If you do not accept these Terms and Conditions, please do not enter the Contest.

3. **HOW TO ENTER:** The Contest begins on 26<sup>th</sup> December 2017 at 0:00:00AM GMT +8 Malaysian Time and ends on 15<sup>th</sup> February 2018 at 11:59:59PM GMT +8 (the “Contest Period”). Any entries after 15<sup>th</sup> February 2018 at 11:59:59PM GMT +8 will be disqualified.

3.1 The mechanics for the Contest are as follows:

- i. To participate in this contest, Entrants are required to authorise the Contest application to access their Facebook profiles, complete the Contest registration form, and agree to the Terms and Conditions of the Contest.
- ii. By default, each Entrant will be awarded a daily Free Play for a chance to find winning tiles (valid for Tier 2 prize only).
- iii. Entrants can claim extra Free Plays by inviting their Facebook friends to the Contest. One (1) extra Free Play is awarded for one (1) successful friend invite. Entrants are limited to a maximum of one (1) extra Free Play per day.
- iv. Entrants can increase chances of winning Tier 1 and Tier 2 prizes by claiming Special Plays. Three (3) Special Plays can be redeemed with every purchase of any Depex range of products. Entrants are limited to a maximum of one (1) round of redemption per day, i.e. a total of three (3) Special Plays per day.
- v. Free Plays and Special Plays cannot be accumulated and, if unused, will be forfeited at 11:59:59PM on the calendar day they were granted.

- vi. To redeem Special Plays, purchase of any Depex range of products MUST be made and able to provide the printed original receipts or proofs of purchase upon request.

4. Only the authorized account holder registered under the email address (who completed the act of entering) may participate in the Contest and/or be eligible for a Prize (each an "Entrant" and collectively "Entrants"). Limit of one (1) registration per entrant. Any attempt by any entrant to obtain more than one (1) registration by using multiple/different Facebook accounts, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute pertaining to any registration, the authorised account holder of the Facebook account used to register will be deemed to be the registrant or participant. 5. The Business Page's database clock will be the official timekeeper for this Contest. In the event of any dispute pertaining to the identity of any Entrant, the relevant Entry will be deemed submitted by the authorised account holder of the applicable email address used to enter.

6. SELECTION OF WINNERS: Entrants who find the winning tiles and the respective Prizes (the "Winners") are subject to the following:

- i. Upon hitting a winning tile, Entrants will be presented a question at random which must be answered correctly in order to proceed.
- ii. Upon giving the correct answer, all Winners will be sent confirmation emails except for Winners of Tier 1 Prizes who will be required to undergo a verification process.
- iii. Winners of Tier 1 Prizes will be required to present the printed original receipts or proofs of purchase. Failure to do so upon request will result in disqualification.
- iv. Printed original receipts or proofs of purchase MUST be dated no earlier than the commencement time and date of the Contest and no later than the time and date of winning.
